How to qualify for the Premium Holiday:

- Must be NEW coverage
- Groups with 10-150 lives
- Coverage must be effective between July 1, 2010 and January 1, 2011 (includes January 1st effective dates)
- Only applies to Basic Life, Basic AD&D, Dependent Life and Short Term Disability
- For groups adding an eligible new line of coverage, the Holiday will only apply to the new coverage (not existing policies)

How it works:

Once Regence Life and Health receives the sold paperwork, a non-cash payment will be applied to the account in the amount of the first month's premium. No binder check required!
